	Consultation has commenced with Board Member organisations around what are considered to be some of the City's main challenges regarding the population's Health and Wellbeing and what would be the priority actions to address some of the inequalities. Main overarching themes currently being considered are: • Improving lifestyle choices to reduce the risk of cardiovascular disease (including coronary heart disease and circulatory disease) • Improve end of life care • Build resilience within individuals and communities • Reduce poverty (including child poverty and fuel poverty) • Improve the quality of life for those people who live with impairments, inequality and vulnerabilities • Creating a fully inclusive society (including reducing loneliness and isolation) We asked for more information about the Better Care Fund, to include outcomes and impact. A paper will be shared with members. We also raised concerns about proposed cuts to the City's drugs and alcohol services and the lack of equality and quality impact assessments. Stoke-on-Trent is now the 2 nd worst in the country for infant mortality and we were informed that a review is being conducted which will include partners. We will share our pregnancy and maternity report once it is finalised. Emphasised that this will contain patient experience which is key to service improvement.

Stoke-on-Trent City Council are proposing bringing commissioned mental health services for adults in-house and delivering through local, integrated teams which "will mean a more holistic and enabling service for mental health service users". The council representative also said "We are working with combined to look at how money is spent and what the issues are, there have been many restructures and it is very clinical and we need to know what is delivered in Social Care overspent year on year and can't work out what they are spending money on"

Item 4 - Work Programme Project Updates

Annual priorities 2020/21

Prior to Covid-19 and on 26 February 2020 we agreed the following 2020/21 priorities based on feedback and intelligence from our residents:

- Autism pathway for children and adults including transition
- Primary Care Access and public experience of the pathway
- Prioritise our outreach and engagement with seldom-heard groups

Due to the impact of Covid-19 we will need to adapt our workload in response to 'reactive priorities'. Therefore, we will only complete targeted work on the priorities if we have capacity to do so as we will prioritise reactive work in response to local health and care issues as they inevitably arise throughout the year.

We will also carry-out 'call-outs for evidence' based on local and Healthwatch England intelligence.

We launched our Covid-19 Impact survey on 13 July 2020. This survey was developed in collaboration with Stoke-on-Trent City Council, Staffordshire County Council and Health. https://engagingcommunities.researchfeedback.net/s.asp?k=159462856403

Publication of the following in 2019/20 was delayed due to Covid-19 and stakeholders focussing on the response to the latter resulting in comments on reports not being a priority. The following reports will now be published in 2020/21.

- 4. Patient experience of community mental health services
- 5. Patient experience of prescriptions
- 6. Patient experience of NHS and social care in the home Field work was ongoing with a deadline of 13 March with analysis and report writing scheduled to be completed by end March/early April. We identified possible opportunities for targeted face to face engagement to maximise response rate. Due to Covid-19 and cancellation of all face to face engagement activities we were unable to continue with planned targeted engagement. Our online survey remained open until 20 April (deadline was extended to allow for a higher return rate). Due to the low response rate we will summarise findings/feedback and share a short paper with providers/commissioners.

Item 5 - Intelligence/Feedback Update - Public Issues

Top areas for feedback received are:

- Shielding and access to prescriptions
- Access to blood tests
- Primary Care

Individuals are signposted and supported as needed. The intelligence received is recorded on our CRM to identify themes/trends, inform our priorities and it is shared with relevant providers/commissioners/local authority and CQC on an ongoing basis with request for feedback.

Item 7 - Health and Wellbeing Board Update
